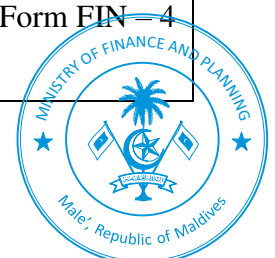


2. Section 3 - Evaluation and Qualification Criteria (2.3.3 Financial Resources - Revised as follows)
