Clarification 01

Q1. Regarding the Expression of Interest submission, is it possible that one company participates in two different consortiums? Is participation of companies exclusive to one sole consortium?

A Consultant shall not submit more than one Proposal, either individually or as a joint venture partner in another Proposal. If a Consultant, including a joint venture partner, Section III. Governance 9 World Bank Procurement Regulations for IPF Borrowers submits or participates in more than one Proposal, all such Proposals shall be disqualified. However, this does not preclude a firm's participation as a sub-consultant, or an individual's participation as a team member, in more than one Proposal when circumstances justify and if permitted by the request for proposals (RFP) document.

Q2. Could you please clarify whether it is allowed for a sub-contractor (not partner in a joint venture) to participate in multiple EOIs for this tender, or this will lead to exclusion of those EOIs that such a consultant appears in.

Refer to our response to Query 1.

Q3. Is it possible to include in the team of experts an expert who is working at an affiliated agency of the Ministry of Environment and Energy?

An expert who is working at an affiliated agency of the Ministry of Environment and Energy can participate unless he/she is directly or indirectly involved in any part of: i. the preparation of the TOR for the assignment; ii. the selection process for the contract; or iii. the supervision of the contract.

Q4. We would like to clarify if there are more background information about the project which we could receive before the submission deadline, as well as we would like to clarify if there are any formalities to the form of the submission for instance in the means of templates.

There is no specific format for the Expression of interest. It should be a letter expressing your interest with supporting documents demonstrating qualification and experience. You may be guided by the shortlisting criteria provided in the REOI. There will be no page limit and no requirement for CVs at this stage.
