1. We kindly request your clarification on the following queries: Claim ratio?	This information is not maintained by People's Majlis Secretariat. Furthermore, the claim ratio is not a component included in the information provided under this tender.
2. Inpatient and outpatient claimed amounts?	The inpatient and outpatient claimed amounts are not included in the information provided under this tender.
3. (Point 3.1.1) In this point, does "Meals" refer specifically to nutritionist-recommended meals that are directly related to the member's diagnosed medical condition?	A minimum stay of 90 days will be provided at a daily rate of maximum MVR 3,000, inclusive of food and accommodation. Meals are included and not limited to doctor-prescribed conditions.
4. If we submit more than one Specific Experience Form, will the points remain the same, or will additional points be awarded?	Refer to Instruction to Tenderers (ITT), clause 17 (b). No score will be awarded under this clause. However, bidder must meet the minimum criteria provided in the above stated clause.
