Interested bidders shall register with the Ministry of Finance for **each project** from **27**<sup>th</sup> **February 2020 to 5**<sup>th</sup> **April 2020** between **0830hrs and 1200hrs** on all working days, by: (a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to <u>ibrahim.aflah@finance.gov.mv</u>; <u>and</u>, (b) submitting in person or e-mailing the following information:
  - Name and Address of the Bidder
  - Name, e-mail ID and telephone numbers of the Contact Person(s)
  - Copy of the Payment/Transaction Receipt.

The Employer shall not be liable for any information not received by the Bidder. It is the Bidder's responsibility to verify the website for the latest information related to this Bid.
- 5. The Bidder shall furnish a Bid Security for each of the lot for the amount specified in Clause 1 of this Invitation. The Bid security shall be valid for 148 days from the date of bid opening.
