The Government of Maldives has applied for a grant from the Asian Development Bank (ADB) for the **Kulhudhuffushi Harbor Expansion Project** (the project) and intends to apply a portion of its proceeds to engage individual consultants to support the Ministry of Housing and Infrastructure (the Employer) in the project implementation.

The Ministry of Finance and Treasury wishes to contract a **Project Director (Local)** and will be recruited to lead the Project Management Unit (PMU) for the project, which will perform all project management and implementation activities throughout the detailed design, procurement, construction, technical assistance, commissioning stages and post-defect liability periods. PMU and MHI will be assisted by a Project Management Consultant (PMC) team in performing general project management, procurement, detailed design, construction supervision and monitoring activities

The candidate should have a master degree or equivalent in engineering or any related fields, possess at least 10 years of experience in general infrastructure projects with significant managerial responsibilities. This experience should include at least 5 years in harbor projects. Experience in working for international donor funded projects will be preferred.

Successful candidate will be paid an all-inclusive monthly fee up to MVR 46,260.00 by the project. The estimated duration of this consultancy is 26 calendar months.
