The Government of the Republic of Maldives has received financing from the International Development Association The World Bank towards the implementation of Maldives Clean Environment Project (implemented by the Ministry of Environment, Climate Change and Technology), and intends to apply part of the proceeds for Supply and delivery of Island Waste management Equipment for Islands of Zone 2.
- 2. The Ministry of Finance on behalf of Ministry of Environment, Climate Change and Technology (the Employer), invite bids from eligible and qualified bidders for the Procurement of Waste Collection Vehicles for Selected Islands
- 3. International bidders shall seek all applicable **Foreign Investment Registration** and **Foreign Direct Investment Policy** requirements of Maldives prior to bid submission.
- 4. The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa Five Hundred), for the project from <u>24<sup>th</sup> August 2022 to 4<sup>th</sup> October 2022</u> by: (a) payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa Five Hundred), through our online payment portal Ban'deyri Pay (<u>https://bandeyripay.finance.gov.mv/</u>) and, (b) e-mailing the following information to the below given e-mail addresses:

- The Bidder shall furnish a bid security of <u>USD 3,375.00</u> (Two Thousand United Sates Dollars or equivalent in Maldivian Rufiyaa) for the project. The Bid security shall be valid for 148 days from the date of bid opening.

Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" of July 2016, Revised November 2017 ("Procurement Regulations"), and is open to all Bidders as defined in the Procurement Regulations.
