6. The Bidder shall furnish a bid security of **MVR 25,000.00**, which shall be valid for 119 days from the date of bid opening. The amount of performance security shall be 5% of contract price.

Bids shall be valid for a period of 91 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified above in Clause 4 of this Invitation for Bids, on or before **1100 hours Maldivian time on 07th September 2016**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
