4. The Bidder shall furnish a bid security for each of the project for the amount specified in clause 1 of this Invitation. The Bid security shall be valid for 118 days from the date of bid opening. The amount of performance security shall be 5% of contract price.
5. A pre-bid meeting will be held on **17<sup>th</sup> August 2016 at 1000 hrs** Maldivian time at the Public Procurement Section Meeting Room of the Ministry of Finance and Treasury. Any clarifications to the project may be sent to the address in clause 7 of this invitation for bids on or before 1330 Hours Maldivian Time on Thursday, 18<sup>th</sup> August 2016.

Bids shall be valid for a period of 91 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified below in Clause 7 of this Invitation for Bids, on or before **1000 hours Maldivian time on 25<sup>th</sup> August 2016**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
