### **REQUEST FOR EXPRESSION OF INTEREST**

The Ministry of Finance and Planning on behalf of Ministry of Construction, Housing and Infrastructure, wishes to revise and extend the invitation for Bids Ref (IUL)13-K/13/2025/308 (10<sup>th</sup> December 2025) and invites interested firms to submit their expressions of interest in providing **Consultancy Services for Rasmale' Transport Master Plan – Project Preparation & Feasibility Study.**
2. The objective of this consultancy is to formulate a comprehensive Transport Master Plan for Rasmale', with the overarching goal of establishing safe, reliable, and sustainable connectivity between the capital city and Rasmale'. The study shall also evaluate a range of alternative and complementary transport solutions spanning land, sea, and air.

Interested firms must provide specific information which demonstrates that they are fully qualified to perform the services (background of the proponent's technical expertise, description of any similar assignments undertaken, experience in similar conditions, availability of appropriate skills among staff, value of those services etc.) The shortlisting criteria is set out in the Terms of Reference (TOR).
4. A Consultant will be selected in accordance with the Quality and Cost-based Selection (QCBS) method set out in the Public Finance Regulation of Maldives.
5. Prospective firms are requested to submit a letter of interest and a proposal that includes but not limited to the requirements outlined in the Terms of Reference (TOR).
6. The Employer will prepare a short list of consultancy firms based on the Expression of Interest (EOI)'s and detailed Request for Proposal (RFP) will be released to the shortlisted firms.
