

2. Is there any space for material storage?	Temporary sites will be provided for all construction related purposes
3. Can we use Manufacture sand for the concrete work and other work like masonry and screeding etc?	Yes
4. Can we use local sand made blocks or equivalent for masonry work?	In general, the sand used for masonry work shall comply with BS 1200 and be free from any deleterious substances. The use of sand which has been in contact with sea water shall not be permitted unless it has been washed adequately, so that the total quantity of soluble salts does not exceed 0.3%.
	The Contractor shall provide test certificates providing the average minimum crushing strength of the blocks prior to the commencement of the construction.
	Further test certificates shall be provided as required by the Client to ensure that all batches of blocks have the minimum specified crushing strength.
