1. The Ministry of Finance (MoF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), now invites sealed Bids from eligible and qualified bidders for the following work.

2. **International Competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives. Qualifications requirements are stated in the Bidding Document.
3. Interested bidders shall register with the Ministry of Finance, between **08<sup>th</sup> April 2019 to 07<sup>th</sup> May 2019 between 0830hrs and 1200hrs (During Ramazan: 1000hrs to 1200hrs)** on all working days, by: (a) payment of a non-refundable Registration fee of **MVR 1,500.00** (Maldivian Rufiyaa One Thousand Five Hundred) or USD 100.00, by cash/cheque at the Ministry of Finance between 0830hrs and 1200hrs on all working days, or by electronic transfer to a designated bank account, information of which can be requested through email to [ahmed.jinah@finance.gov.mv](mailto:ahmed.jinah@finance.gov.mv); and, (b) submitting in person or e-mailing the following information:

5. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.
6. Commencing on 30<sup>th</sup> March 2019, only a listed member of the National Contractors Registry will be eligible to participate in this tender. Only Contractors who has been qualified for the above mentioned grades in clause 1 of this invitation will be eligible to participate for this tender.
