



MONTHLY FISCAL DEVELOPMENTS

April 2024

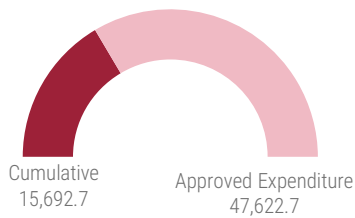
Revenue and Grants for April 2024 is 2,700.2 million, which is an increase of 14.1 percent compared to April 2023.

Total Expenditure for April 2024 decreased by 1.1 percent compared to the same period of 2023. Compared to April 2023, Capital Expenditure was 0.4 percent lower while Recurrent Expenditure decreased by 1.3 percent.

Fiscal Balance for the month of April 2024 is an overall deficit of MVR 1,004.3 million.

IN MILLIONS MVR

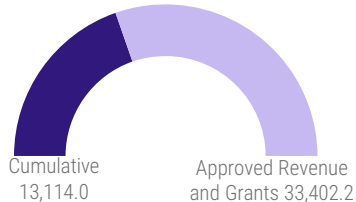


EXPENDITURE COMPOSITION - APRIL
