INVITATION OF BIDS

Design, Supply, and Installation of a Waste incineration plant

1. The Government of the Republic of Maldives has received financing from the Abu Dhabi International development (ADFD) and intends to apply portion of the financing for eligible payments under the contract for **Design, Supply, and Installation of a Waste incineration plant**
2. The Ministry of Finance and Treasury (MOFT) on behalf of the Ministry of Environment and Energy (MEE), now invites sealed Bids from eligible Bidders for Design, Supply and Installation of a Waste Incineration plant with energy recovery in Addu city
3. **International competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives, Single Stage One envelope bidding procedure.
4. Qualifications requirements are stated in the Bidding Document.
5. The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of **MVR 1,500.00** (Maldivian Rufiyaa One Thousand Five Hundred) for each project from **21st January 2018 to 27th February 2018** between **0830hrs and 1300hrs** on all working days. A complete set of bidding documents in electronic format shall be available for download from the Ministry of Finance and Treasury website www.finance.gov.mv.
6. The Bidder shall furnish a Bid Security of **USD 10,000.00** (or equivalent in MVR) which shall be valid for 28 days beyond the validity of the Bid. **The Amount of Performance Security required under the contract shall be 5% of the Contract Price. An Advance Payment of 10% of the contract price shall be provided upon submission of an Advance Payment Guarantee.**
7. Any clarifications to the project may be sent to the address in clause 9 of this invitation for bids **on or before 1300 Hours Maldivian Time on Thursday, 1st February 2018**
8. Bids Shall be Valid for a period of **120 days** from the date of Bid of Opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in the clause 9 of this Invitation for Bids, on or before **1100 hrs, Maldivian Time on 28th February 2018**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
