

1			I would like to request for further information on the R. Vandhoo waste management project regarding the per day shredding capacity of the shredder required.	40 tons/day
2			We are an international company, who doesn't have an office in Maldives and yes, we would be using a local contractor to carry out all the works required, and could you confirm if we are liable for the GST or local taxes so we could quote you accordingly.	Bidders should visit <a href="https://mira.gov.mv/">https://mira.gov.mv/</a> and confirm with the relevant authority to confirm the taxes they are applicable for. Custom duty shall be exempted and the Employer will assist in providing a letter of exemption for the goods brought in from abroad.
3			Section 6 - Purchaser's Requirements, 1. Scope of Supply of Goods and Services.
