INVITATION FOR BIDS

1. The Ministry of Finance and Treasury, on behalf of Ministry of Housing and Infrastructure (the Employer), did not receive **sufficient bids** to the Invitation for Bids Ref (IUL)13-K1/13/2016/15 and therefore wish to **annul the referred bidding process and** re-invite bids from eligible and qualified bidders for the following works.

2. Bidders shall quote for all the projects.
3. The bidder shall be a listed member of the National Contractors Registry and shall satisfy one of the following grades in order to be eligible to participate in this tender,

GC01-1, GC01-2 and GC01-03

4. The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of **MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred)** for the package from **13th March 2016 to 05th April 2016** between **0830hrs and 1330hrs** on all working days. A complete set of bidding documents in electronic format shall be available for download from the Ministry of Finance and Treasury website www.finance.gov.mv
5. The Bidder shall submit the Tax Clearance Report, which shall be obtained from Maldives Inland Revenue Authority (MIRA). This document shall be dated no earlier than 10 (Ten) working days prior to the bid submission date.
6. The Bidder shall furnish a bid security for each of the project for the amount specified in clause 1 of this Invitation. The Bid security shall be valid for 118 days from the date of bid opening. The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.
7. A pre-bid meeting will be held on **20th March 2016 at 1100 hrs.** Maldivian time at the Public Procurement Section Meeting Room of the Ministry of Finance and Treasury. Any clarifications to the project may be sent to the address in clause 9 of this invitation for bids on or before 1330 Hours Maldivian Time on Tuesday, 22nd March 2016.

8. Bids shall be valid for a period of 90 days from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in Clause 9 of this Invitation for Bids, on or before **1100 hrs Maldivian Time on 06th April 2016**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
