The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.
6. A pre-bid meeting will be held on **Monday 19<sup>th</sup> September 2016 at 1100 hrs** Maldivian time at the Public Procurement Section Meeting Room of the Ministry of Finance and Treasury. Any clarifications to the project may be sent to the address in clause 8 of this invitation for bids on or before **1330 Hours** Maldivian Time on **Tuesday, 20<sup>th</sup> September 2016**.

Bids shall be valid for a period of **120 days** from the date of bid opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in Clause 8 of this Invitation for Bids, on or before **1100 hrs Maldivian Time on 29<sup>th</sup> September 2016**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
