MONTHLY FISCAL DEVELOPMENTS

Revenue and Grants for February 2024 is 2,868.7 million, which is a 15.1 percent decrease compared to February 2023.

February 2024

Total Expenditure for February 2024 increased by 8.6 percent compared to the same month of 2023. Compared to February 2023, Capital Expenditure decreased by 6.8 percent while Recurrent Expenditure increased by 13.8 percent.


Fiscal Balance for the month of February 2024 is an overall deficit of MVR 768.8 million.

EXPENDITURE COMPOSITION - FEBRUARY










REVENUE AND GRANTS COMPOSITION -FEBRUARY
