INVITATION FOR BIDS

Subject: Design and Build of Revetments in N.Holhudhoo and R. Maduvvari, Maldives

1. The Government of the Republic of Maldives has allocated funds in the Annual Budget 2013 toward the provision of coastal protection structures on N.Holhudhoo and R.Maduvvari, and intends to apply the allocated funds for eligible payments under the contracts for provision revetments at these islands.

2. The Government of Maldives, represented by National Tender Board (NTB), Ministry of Finance and Treasury (MOFT) on behalf of the Ministry of Environment and Energy (MEE), now invites sealed Bids from eligible Bidders for the works given below. Bidding is open to all bidders who fulfill qualification requirements given in Section 3 of Bid document, briefly stated below.

3. International competitive Bidding will be conducted in accordance with the National Tender Board's single stage two Envelope bidding procedure.

The Bidding document, in the English language, maybe purchased by interested Bidders on the submission of a written application and upon payment of a non-refundable fee of MVR 2,500.00 (Maldivian Rufiyaa Two Thousand Five Hundred Only) in cash or by demand Draft in favor of Ministry of Finance and Treasury, Maldives during normal office hours on all working days from 30th June 2013 to 28 July 2013. The bidders who desire bid document through courier are required to pay an additional US\$ 50.00 or its equivalent in Maldivian Rufiyaa as courier charges. The employer and or his representative will not be responsible for postal delay if any for any reasons thereof.

6. A pre-bid meeting will be held on 15th July 2013 at 1000 hours Maldivian time at the Ministry of Finance and Treasury. Bids must be delivered to the address above on before 1100 hours, on 30th July 2013. All bids must be accompanied by a Bid security as indicated in the data table above for each respective package in Maldivian Rufiyaa (MVR). Late bids shall be rejected. Technical Proposals of Bids will be opened at 1100 hours on 30th July 2013 in the presence of the Bidders' representatives who choose to attend. Price proposals of technically compliant bids will be opened subsequently at a date and time to be intimated subsequently by Ministry of Finance and Treasury. Ministry of Finance and Treasury will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
