### **REQUEST FOR EXPRESSION OF INTEREST**

#### **Consulting Services for Marine Renewable Energy (MRE) Roadmap and Ocean Renewable Energy (ORE) Pilot Project in Maldives**

The Government of the Republic of Maldives has received financing from Asian Development Bank (ADB) toward the cost of **Accelerating Sustainable System Development Using Renewable Energy (ASSURE) Project** and intends to apply part of this financing for the services of **Consulting Services for Marine Renewable Energy (MRE) Roadmap and Ocean Renewable Energy (ORE) Pilot Project in Maldives**.
2. The main objective of this assignment is to prepare the Marine Renewable Energy (MRE) Roadmap and support the preparation and implementation (limited to pre-development activities) of an Ocean Renewable Energy (ORE) Pilot Project in Maldives.
