INVITATION FOR BIDS

Development of Logistics Building at Male' Industrial Village

1. The Ministry of Finance and Treasury (MOFT) on behalf of the Ministry of Housing and Infrastructure (MHI), decides to cancel the Invitation for Bids (Reference Number: (IUL) 13-K1/13/2016/236) and re-invites to submit bids for **Design and Build of Pre-fabricated Logistics Buildings under Contractor Finance in the Male' Industrial Village**.
2. The Developer's services shall consist of providing both Architectural and Engineering (A/E) design services and Construction services related to the development of an area of 20309 square meter Prefabricated warehouse and logistics buildings, allocated in to four (4) lots as follows and bidders have option to bid for any one or more lots:

| Lot 4 | Block 3, Block 7, Block 8 & Block 9 | USD 110,000.00 or equivalent |

The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) to the Public Procurement Section, Ministry of Finance and Treasury, **February 15, 2017 till March 7, 2017** between **0830hrs and 1300hrs** on all working days. Bank details shall be available upon request. A complete set of bidding documents in electronic format shall be available for download from the Ministry of Finance and Treasury website www.finance.gov.mv.
4. Any **clarifications** to the bid may be sent to below given mail addresses on or **before February 22, 2017 at 1400 hours**.
5. The Bidder shall furnish a bid security stated in the above table for the specific lots and it shall be valid for 208 days from the date of bid opening.
6. Bids Shall be Valid for a period of 180 days from the date of Bid of Opening and shall be delivered to the Ministry of Finance and Treasury at the address specified in the clause 7 of this Invitation for Bids, on or before **1300 hrs**, Maldivian time on **March 8, 2017**, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening. Late bids will be rejected.
