- 3. The bidder shall be a listed as a member of the National Contractors Registry and shall satisfy one of the following grades in order to be eligible to participate in this tender.

The Bidder shall be registered to submit a bid upon payment of a non-refundable Registration fee of MVR 1,500.00 (Maldivian Rufiyaa One Thousand Five Hundred) for the package from 7th August 2016 to 7th September 2016 between 0830hrs and 1330hrs on all working days. The amount of performance security shall be 5% of contract price. An advance payment of 15% of contract price will be provided upon submission of an advance payment guarantee.

- 7.
