- 6. The Bidder shall furnish a Bid Security for each of the project for the amount specified in clause 1 of this Invitation. The Bid Security shall be valid for 28 days beyond the validity of the Bid.

Bids shall be valid for a period of 120 days from the date of bid opening and shall be delivered to the Ministry of Finance at the address specified in Clause 08 of this Invitation for Bids, on or before 1300 hrs Maldivian Time on 25th March 2020, at which time they will be opened in the presence of the Bidders who wish to attend the bid opening.
