1. The Ministry of Finance (MOF) on behalf of the Ministry of National Planning and Infrastructure (MNPI), now invites sealed Bids from eligible and qualified bidders for the following works.

2. **International competitive Bidding (ICB)** will be conducted in accordance with the Public Finance Regulation of Maldives, Single Stage Single envelope bidding procedure under ICB. Qualifications requirements are stated in the Bidding Document.
