#### Terms of Reference

#### (Consultancy No: MV/PSPAF/C 16)

#### A. Background

- 1. The Maldives Pension Administration Office (MPAO), Government of Maldives (GOM), has been appointed as the Implementing Agency for World Bank financed Maldives Pension and Social Protection Administration Project.
- 2. The Pension and Social Protection Administration Project is mandated to support the implementation of Recipient's National Pension Act, to strengthen the institutional capacity of key agencies responsible for implementing the National Pension Act, and to develop the process and platforms required for the delivery of social protection programs.
- 3. The Government of Maldives (GoM) has received a credit from the International Development Association (IDA) towards the cost of the Maldives Pension and Social Protection Administration Project (PSPAP), and intends to apply part of the proceeds of this credit to payments under the contract for a consultancy for the Strengthening of the Public Accounting System Project.

## **B.** Objectives

4. The objective of the Strengthening of the Public Accounting System Project is to modernize the Public Accounting System (PAS) to enable it to improve the financial management, enhance public sector governance, and strengthen its accountability.

## C. Scope of Service.

- i. To help Treasury and Public Accounts Division (TPAD) establish an efficient organization to support business processes relevant to the SAP landscapeinstalled at TPAD.
- ii. To review and audit the current SAP landscape(Version Details in Annex 2) at TPAD.
- iii. Configuration of SAP Solution Manager according to specifications provided in Annex 1.
- iv. To upgrade the SAP landscape of the TPAD to the most current EHP level.
- v. To upgrade the current database of the SAP landscape from Oracle 10.2.0.2.0 to 10.2.0.5.0.
- vi. Migrate the SAP Oracle database of the SAP landscape to another high storage drive within the same storage area network.
- vii. To synchronize the ECC landscape (Development, Quality Assurance and the Production) in terms of its configurations and roles.
- viii. Run test scripts along with the functional team leads to verify ongoing business process and functions are intact in their respective SAP modules due to the upgrade of EHP level

and solve any identified issues (including but not limited to ABAP customized program errors and configuration errors due to the upgrade).

- ix. Resolve the issues in the implemented SAP modules identified by the TPAD in Annex 3 and also other issues that may be found after the review and audit process (point ii above).
- x. To help ensure the SAP Landscape at TPAD is performing efficiently to support its business processes.
- xi. Involve and train ICT Staff in configuring Solution Manager and upgrading EHP level (this will include the ECC landscape synchronization process).
- xii. Involve and train functional staff in solving problems identified in the issues list (Annex 3) and other problems that may be identified during the review and audit or the project inception phase.

## **D.** Schedule of completion of tasks

i. The selected firm would be responsible for following key deliverables.

## Tasks

- a. Review and audit the current SAP landscape at TPAD,
- b. Configuration of SAP Solution Manager according to specifications provided by TPAD.
- c. Upgrade the SAP landscapeto the latest EHP level (simultaneously synchronize the ECC landscape -Development, Quality Assurance and the Production in terms of its configuration and roles) and train technical staff on these configurations and upgrade.
- d. Upgrade Oracle database from 10.2.0.2.0 to 10.2.0.5.0 and migrate to another high storage drive within the same storge area network.
- e. Guide Key staff in identifying issues that may arise due to the EHP level upgrades and solve issues if any.
- f. Resolve the issues in the implemented SAP modules identified by the TPAD in Annex 3 and also other issues that may be found after the review and audit process (point ii, section C).
- ii. To carry out these tasks, an international firm is required for the period from May to September 2013.

## E. Services and facilities to be provided by the client

- i. MoFT would communicate the progress to the involved parties and ensure all necessary support to the Consultant for the timely completion of the assignment.
- ii. MoFT shall ensure that office space and office facilities-local calls, internet connection, general stationery, support staff and all other relevant information for the completion of the task is made available to the selected party on a timely manner.

## F. Output and Deliverables

- i. Complete the Review and Audit of the current SAP landscape.
- ii. SAP Solution Manager configured according to the specifications provided by the TPAD.

- SAP landscape upgraded to the latest EHP level and ECC landscape (Development, Quality Assurance and the Production) synchronized in terms of its configurations and roles.
- iv. Database upgraded from Oracle 10.2.0.2.0 to 10.2.0.5.0.and migrated to another high storage drive within the same storage area network.
- v. Solved all issues that may have come up due to EHP level upgrade.
- vi. Solved all issues identified by TPAD in Annex 3 and issues found after the review and audit process (point ii, section C).
- vii. Knowledge transfer and documentation of all activities in section C.

## G. Composition of Review Committee to Monitor Consultant's Work

During the course of the project, the Consultancy Firm is expected to work in the premises identified by MoFT, and the consultant shall report to the Financial ControllerofMoFT. The focal point assigned by MoFT would communicate the progress to the Project Team of the MoFT which then formulates the conclusion to be communicated to all the involved parties. The assigned staff will provide all necessary support to the Consultant for the timely completion of the assignment.

## H. Procedure for Review of Outputs

An activity will be considered complete once a sign off is obtained from the respective Government team leads for each module. The government will be given a time period of 2 weeks to accept/reject a delivered task by the contractor.

## I. Required Expertise and Qualifications

Consultants of the selected firm should have minimum 5-6 year's expertise knowledge of SAP software in Public sector accounting, including but not limited to the following SAP modules:NetWeaver/BASIS, ABAP, Human Resources – Payroll (HR), Material Management (MM), General Ledger (GL), Accounts Payable (AP),, Funds Management (FM), Assets Management (AM), Projects System (PS) , Controlling (CO)and Business Intelligence (BI).

- i. Consultants of the selected firm should be SAP certified in their respective SAP module/modules with minimum 5-6 years of experience.
- ii. Familiarity of public sector treasury, accounting and budgeting systems.
